# Scope of Work

The School Improvement Specialist will be responsible for:

- Developing instruction: Creating and implementing effective ELA programs for teachers and students
- Modeling: Demonstrating evidence-based instructional strategies for teachers
- Analyzing data: Using data to help teachers differentiate instruction and identify students who need extra help
- Providing resources: Helping teachers find effective resources for their classrooms
- Monitoring progress: Tracking student progress through assessments

#### ELA coach may also work on:

- Developing and coordinating specific Amplify ELA curriculum
- Designing and implementing ELA interventions aligned with Amplify ELA curriculum
- Teaching teachers how to accommodate and differentiate their instruction
- Conducting comprehensive needs assessments to identify areas for improvement.
- Implementing goals from the strategic plans for school improvement.
- Providing professional development and coaching to teachers and staff.
- Monitoring and evaluating the effectiveness of improvement strategies.
- Collaborating with school leadership to align improvement initiatives with school goals.
